We are pleased to inform that in the meeting of Committee of Administration held on 3rd March, 2017, it has been decided to abolish the Council Charges on FOB value of exports w.e.f. 01.04.2017. Accordingly, the rate of Annual Subscription has been revised w.e.f. 01.04.2017.

Further, this is to inform that your membership of the Council is going to expire on 31st March, 2017. As per Bye-laws of the Council, members should pay Annual Subscription latest by 30th April in each year. You are, therefore, requested to send your membership fee for the year 2017-18 alongwith Registration-Cum-Membership-Certificate (RCMC) for renewal upto 31.03.2018.
